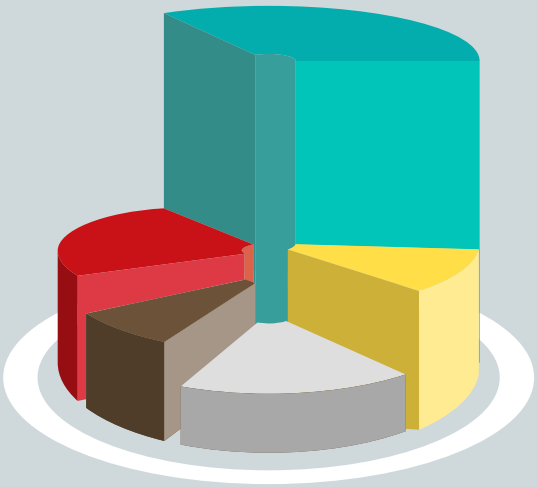

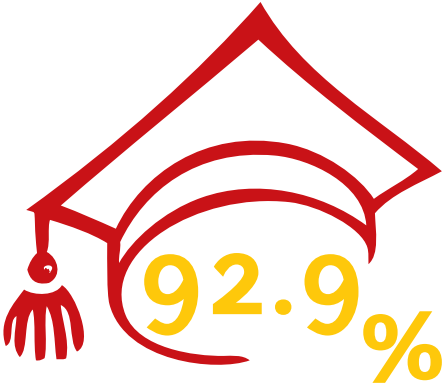

92.9% Five-Year Graduation Rate!

Finley School District has the highest graduation rate in the Tri-Cities! Now at 92.9%, our five-year graduation rate has increased by nearly 16% since 2010.
